

Byelaw 5

Standing Committees

Role and General Arrangement

Role

- 1. Standing Committees exist to promote the views and interests of, and organise activities for, specific sections of the Members of the Students' Association.
- 2. Devolve responsibility for their remits to the Sabbatical Officers if temporarily vacant.
- 3. Produce monthly reports to Student Council to inform members of their activities.
- 4. Help support the implementation of relevant policies passed at Student Council, General Meetings, Annual General Meetings and Referendum.

Membership

- 1. All full members of the Students' Association are eligible to be elected onto a Standing Committee, unless otherwise stated due to specific requirement required such as, but not limited to, degree programme.
- 2. All full members of the Students' Association are eligible to join a Standing Committee as an Un-Elected Regular Member, excluding Sabbatical Officers.
- 3. An Un-Elected Regular Member is someone how has attended a minimum of 3 meetings consecutively and participated actively within the Committee. If an Un-Elected Regular Member misses a meeting, it is up to the elected membership to decide if they retain their Un-Elected Regular Member status.
 - a. An Un-Elected Regular Member shall not vote in decisions regarding funding or affiliations with the Student's Association.

Committee Meetings

1. All Standing Committees' meetings shall be open to all members of the Students' Association, unless stated otherwise along with the reason for a closed meeting.

- 2. Only Elected members of a Standing Committee and Un-Elected Regular Members may vote at a Committee Meeting.
- 3. Quorum for a Committee Meeting is 50% of Elected Members and Un-Elected Regular Members plus one.

Rules

1. A Standing Committee may adopt any rules to regulate its affairs, if said rules adhere to the AUSA Constitution, Byelaws and Policies.

Minutes

- 1. Minutes shall be taken at all meetings by the Vice-chair of the Committee and submitted to AUSA as proof of the meeting taken place.
- 2. Minutes shall be made available upon request from any member of the Students' Association.
- 3. Action may only be taken to implement decisions which have been recorded in the minutes.
- 4. All minutes shall be submitted to Student Council for Routine Approval.

Elections

- 1. Any member of the Students' Association may stand for an Elected Committee Position, unless otherwise stated due to specific requirement required such as, but not limited to, degree programme.
- 2. Nominations for Committee positions will be submitted online via the elections process.
- 3. Voting will be organised online in accordance with the relevant byelaw [add byelaw reference].
- 4. Notice of election shall be published prominently on the AUSA website and in any regular publication of AUSA stating the terms of nomination and voting.

Co-options

- 1. Where vacancies exist following elections, all full members of the Students' Association are eligible for co-option onto a Standing Committee, conditionally that they are not already part of another Standing Committee or do not meet the necessary requirements.
- 2. Co-options will be arranged within individual Standing Committees to fill any remaining Electable positions available within a Standing Committee in a fair and democratic manner.
- 3. Co-options will be routinely approved by Student Council.

- 6. To promote and run charitable events with the aim to fundraise for local charities based in Aberdeen and/or Aberdeenshire and/or national charities with a local department based in Aberdeen and/or Aberdeenshire.
- 7. To allow charities in Aberdeen and/or Aberdeenshire to apply for funding and the Committee votes on which charities to support based on projected fundraising.
 - a. This should be carried out in line with the 'RAG Criteria and Guidance Notes'.
 - b. AUSA Staff is required to be present for this.

- 8. To make sure the profit of all charitable activities will be going to support the charitable causes decided upon and advertised.
- 9. All budget-related decisions must be voted upon by the Committee with the relevant Sabbatical Officer and AUSA staff member present.
- 10. To arrange monthly meetings with the finance staff at the Students' Association to make sure RAG is achieving its yearly objectives.
- 11. To work closely with AUSA staff.
- 12. To arrange meetings with representatives for other student-led charitable campaigns at AUSA.
- 13. To reach out for new partnerships amongst Student Groups, Societies, and Sport clubs.
- 14. To make sure all new partnerships are formed by signing the 'RAG Partnership Agreement' prior to organising a fundraiser.

- 3. The Vice-Chair shall be responsible for liaising with other interest groups, increasing cross-collaboration and engagement.
- 4. All school conveners (excluding the Dentistry convener) and the Vice-Chair are members of the Senatus Academicus (University Senate), where they represent respective student views.
- 5. Liaise with Vice-Principal for Education, and appropriate Deans to ensure efficient dissemination of any academic changes made.
- 6. Members for the Senate sub-committees shall be elected from within the Committee.
- 7. Develop and implement policies related to education.

- 2. The Vice-Chair shall be responsible for liaising with other interest groups, increasing cross-collaboration and engagement.
- 3. Three members of the committee shall be elected onto the Senatus Academicus (University Senate), with a priority to the Postgraduate Representative for Graduate Research School if elected.
 - a. These members should be chosen by the committee on their first meeting following the election.
- 4. Members for the Senate sub-committees shall be elected from within the Committee.
- 5. Liaise with Vice-Principal for Education, and appropriate Deans to ensure efficient dissemination of any academic changes made.
- 6. Develop and implement policies related to postgraduate education.
