

## **Terms and Conditions**

### **AUSA AberGreen and University of Aberdeen Internal Scottish Workplace Journey Challenge**

1. The promoter is: Aberdeen University Students' Association whose registered office is at AUSA Students' Union Building, Elphinstone Road, Aberdeen, AB24 3TU.
2. The competition is open to students of the University of Aberdeen, except employees of Aberdeen University Students' Association and their close relatives.
3. There is no entry fee and no purchase necessary to enter this competition.
4. By entering this competition, an entrant is indicating their agreement to be bound by these terms and conditions.

6. Only individual entries will be considered for this competition.
7. Closing date for entry will be 12pm noon, 17<sup>th</sup> March. After this date, no further entries to the competition will be taken into consideration.
8. No responsibility can be accepted for entries not received for whatever reason. Submissions will only be considered by the panel if the entrant:
  - is registered to the Scottish Workplace Journey Challenge through <https://scotland.getmeactive.org.uk/> and made their profile public (so we can access their miles logged).
  - Has uploaded a minimum of 1 medium-large resolution image to Instagram, picturing the entrant travelling actively. If the entrant does not have social media, they can e-mail submissions to [abergreen@abdn.ac.uk](mailto:abergreen@abdn.ac.uk).
  - Accompanies their photo with a short description of the benefits of active travel
  - Tags @aberdeenunisa and includes the hashtag #activeabdn2020 as the first hashtag in their submission
9. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control.
10. Any changes to the competition will be notified to entrants as soon as possible by the promoter. The promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition. The winner of the competition will receive a Ridgeback Comet bicycle and a digital speedometer.
11. The prize is as stated, and no cash or other alternatives will be offered. The prizes are not transferable. Prizes are subject to availability and we reserve the right to substitute any prize with another of equivalent value without giving notice.

15. The winner will be notified by Instagram DM (or email) within 3 days of the closing date. If the winner cannot be contacted or does not claim the prize within 10 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.

16. The winner must be present and able to collect the prize from the promoter's office within 10 days of notification.

17. The promoter will notify the winner when and where the prize can be collected.

18. The promoter's decision in respect to all the matters about the competition will be final and no correspondence will be entered into.
